## REACH \* Notification June 2018

---

The European Regulation 1907/2006 on the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH \*\*\*) entered into force on 1st of June, 2007.

Most of our products, inclusive their accessories kits, components and packaging, we are placing in the market are “products” in the meaning of REACH.

In accordance with Article 7 our products are not applicable for pre-registration objects. The total amount of the substance present in all articles produced and/or imported, which contain more than 0.1% weight by weight (w/w) of the substance, do not exceed 1 tonne per year. Additional the materials used in our products are not intended to be released under normal or reasonably foreseeable conditions of use.

Article 33 of REACH requires suppliers to inform recipients and respond to consumer enquiries if an article contains more than 0.1% weight by weight (w/w) of any substance on the candidate list of Substances of Very High Concern (SVHC).

In accordance with Article 3 article means an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition. Therefore an article in the meaning of REACH can be part of a product.

Under the scope of Article 59 of REACH the “list of candidates” of very high concern substances (SVHC\*\*) has last been published on the **27th of June, 2018**, by the European Chemicals Agency (ECHA) with currently **191 substances** at
